Administrative Reports

1. District Business Manager - Peggy Quint

Lots of work being done on the meter replacement project with Caselle and Aquahawk. Goal is to have it all in place when the October billing is scheduled to go out.

- 2. District Operation Manager Dave Schneider
 - a. Last Objector to the water case has stipulated out. Water Attorney is somewhat unhappy that this case is not being pursued.
 - b. Johnson Ranch dry-up report is still needed to move forward in selling the property.
 - c. Christmas bonus/Christmas party needs to be discussed. Board will respond later in December.

 After discussion, vote was 5-0 in favor of accepting the Consent Agenda.

- 1. 2022 Budget Update on Draft Copy Dave Schneider covered the changes in the original draft budget. Dave will fine tune the numbers and have the budget ready for presentation at the public hearing on November 4, 2021. Discussion regarding what all should be included in the presentation, i.e., all that the district has done to reduce costs to operate and supply water to our customers and why rates are increasing.
- 2. Second 61 Presentation Chase Weber presented the results of the Gap Audit that was completed a few months ago. Chase stated that RMWSD looks pretty good for a district of this size. His biggest concern was the Shop computer is running on Windows 7 and needs an upgrade. Replacing the computer would be beneficial. The district has a weak backup strategy. A 3-2-1 backup strategy, including off site backups was recommended. Chase will send a cost estimate for the districts needs. Peggy Quint will let the board know as soon as that information is received.
- 3. USDA funding continued discussion Dave Schneider sent USDA \$14.1M WWTP update. He has not heard anything back from Joe Montgomery. RMWSD has been approached with a new design idea called Electro Coagulation. This would be substantially less to build and operate. Dave is meeting with the company on Friday, October 22, 2021. This process could be an alternative for rural Colorado. We are not the only district in Colorado that cannot afford \$14.1M for a plant.
- 4. Iconergy project update project is running quite smoothly!
- 5. Board Stipend Policy Board was given a proposed policy. Board will review and approve on November 4, 2021.
